Overview

As these memberships are being made available after the start of the 2026/27 membership year, they are offered at a pro rata rate reflecting the time remaining in the current year. Annual fees shown are the standard 2026/27 rates; the amount payable will be calculated pro rata based on your joining date, with the membership year running through to 1st March 2027. No joining fee is applicable to any of the categories listed below. All other eligibility requirements, conditions, and club rules apply in full as set out in the terms and conditions on the following page.

Available Memberships

The following membership categories are available. Fees are payable pro rata from your date of joining.

Student	£350	£35	None	Full-time university students only. See T&Cs.
Second Club	£650	-	None	Annual only. Must hold full membership elsewhere. See T&Cs.
Country (25+ miles)	£650	-	None	Annual only. Proof of address required. See T&Cs.
Twilight	£250	-	None	Annual only. Play after 2.30pm, 1 Apr – 30 Sep. See T&Cs.

Renewal

All memberships taken up under this offer will be due for renewal on 1st March 2027 at the full standard annual rate applicable at that time. Members will be contacted in advance of renewal with details of the 2027/28 rates.

Membership Terms & Conditions

The following terms and conditions apply to all mid-year membership categories listed in this document. All members are also subject to the club's general rules and code of conduct.

Second Club Membership

- The member must hold a full playing membership at another golf club.
- If the primary club membership is cancelled or lapses, the club must be informed immediately; this membership will be reviewed and moved to the appropriate category.
- Failure to disclose any change to primary club membership may result in withdrawal of this membership without refund.
- The primary club must be located within 100 miles of the member's permanent residence.
- The cost of the primary membership must be equal to or greater than the value of this category.
- A valid CDH number, along with the name and address of the primary club, must be provided at the point of joining.
- England Golf / affiliated membership fees are not included within this category and will not be covered by the club, as these costs are expected to be covered by the member's primary (home) club.
- Membership is subject to verification and approval by club management.

Country Membership (25+ miles)

- Valid proof of permanent address is required upon joining (e.g. current utility bill or council tax bill).
- The club reserves the right to request proof of address at any point during the membership term.
- Members must inform the club of any change in permanent address; a change may result in a review of membership category and applicable pricing.
- Distance is measured from the club's address to the member's permanent residential address.

Student Membership

- The member must be in full-time education at university level.
- A valid student ID card from a recognised institution must be provided and may be requested for renewal each year.
- Part-time students and apprentices are not eligible, even where studying towards a degree qualification alongside employment.
- The club reserves the right to decline or review eligibility for members over the age of 25 where full-time student status cannot be clearly evidenced.

Twilight Membership

- Play is restricted to after 2:30pm from 1st April to 30th September.
- This membership does not carry over or provide discounted access during the winter period.
- Should a member wish to transfer to a full membership category at any point, the standard joining fee for that category will be payable at the time of transfer.
- No joining fee is payable on the initial Twilight membership.

General Conditions

- All memberships are subject to availability and club management approval.
- Membership fees are reviewed annually; existing members will be given reasonable notice of any changes.
- Monthly memberships will run until the end of the current membership year on 1st March 2027 and cannot be cancelled before this date unless otherwise specified. Please refer to the club's direct debit agreement for full details.
- Pro rata fees are calculated based on the number of days remaining in the membership year from the date the membership is activated.
- Upon renewal on 1st March 2027, the full standard annual rate will apply.
- The club reserves the right to amend, suspend, or withdraw any membership category or offer at any time.
